Dear Mr. Gordon:

On September 2, 2015, the Office of the Governor (the "OOG") received a request under the Public Information Act (the "PIA") from Ms. Emily DePrang<sup>1</sup>. A copy of the request is attached as Exhibit A.

The OOG asserts information responsive to this request is excepted from disclosure under the Public Information Act ("PIA"). Specifically, the OOG invokes all of the exceptions provided by, and the exceptions incorporated into, sections 552.101 through 552.154 of the PIA.

Pursuant to section 552.301(a) of the PIA, this letter is submitted in order to seek a decision as to whether the exceptions apply. To assist in your review, the OOG will provide written comments and the responsive documents, or a representative sample of the responsive documents, not later than the 15<sup>th</sup> business day from the date the request was received.
