Dear Attorney Shea:

Mr. Gareld Duane Rollins, Jr., has been under my care since August 11, 2016, complaining of a history of repeated drug and alcohol relapses, resulting in incarceration. He was not afforded any type of psychiatric or psychological evaluation and treatment until November 2015 in the Texas Department of Criminal Justice (TDCJ) from which he was released in June of 2016.

The repetitive pattern noted above began at approximately 13 years of age which continued into adulthood. The TDCJ intervention in November 2015 constituted an "outcry" statement of early childhood sexual molestation.

The Treatment Plan was, therefore, designed to deal with the repeated history of recurrent drug and alcohol intoxication and to determine if the outcry of childhood sexual molestation had a causal link to it. Further, the Treatment Plan is designed to not only treat the substance abuse disorder and to additionally explore the underlying anlagen.

The Treatment Plan includes the following:

- 1. Individual Psychotherapy Sessions weekly of the Cognitive Behavioral Type (CBT);
- 2. Group Psychotherapy weekly;
- 3. Psychopharmacologic Intervention; and
- 4. Neurotherapy Sessions weekly.

Mr. Gareld Duane Rollins, Jr., has been compliant with all aspects of the Treatment Plan, as a result of which, he has already shown incremental progress. Significantly, he has not had any episodes of intoxication over the 3 months treatment interval which constitutes the longest period of abstinence he has achieved since age 13 with the exception of the time incarcerated in TCDJ. Certainly, this has contributed to the efficacy of the Treatment Plan.

I have concluded that he has been suffering from undiagnosed Posttraumatic Stress Disorder (PTSD) which is now responding favorably to the Treatment Plan. Further, I have concluded diagnostically that the PTSD is a direct result of the childhood sexual traumata he suffered.

Clinically, the response to the treatment modalities of Cognitive Behavioral Therapy, Group Psychotherapy, Psychopharmacologic Intervention, and Neurotherapy have allowed me to professionally conclude that Mr. Gareld Duane Rollins, Jr., is a reliable historian for the childhood sexual trauma to which he was repeatedly and chronically subjected. This history has been unfortunately obfuscated by self-administered maladaptive treatment in the form of intoxication. Even without the intoxication factor, anal penetration of an innocent child is sufficiently traumatic to cause these overwhelmingly painful memories to be defensively repressed and dissociated until a safer time in the name of survival.

The overlay of repeated intoxication at a severity to result in incarceration is an indicator of a person chronically suffering from an unsound mind. This has undoubtedly adversely affected his decision making for years.

Additional corroboration was obtained from interviewing Mrs. Margaret Duryea, the mother of Mr. Gareld Duane Rollins, Jr., on November 8, 2016. She recalled significant behavioral changes starting with early adolescence which she stated she couldn't explain for 40 years. She also stated that in retrospect, she herself felt as if she were a victim: "I was very groomed!"

I feel with years of dealing with PTSD victims both as a clinician and as a teacher that I have been able to remain objective, non-judgmental, and appropriately empathetic.
